“Journalistic Publications and Professional Secrecy

Article 22. *The lawyer must not use the written or spoken press to discuss the matters entrusted to him or to publicize the pieces of the file in the trials in process, unless this is necessary for the correction of concepts or errors when the justice or morals demand it. Once the process is concluded, the Lawyer may publish the documents and actions with his comments on them, in a measured and impartial manner.*

The foregoing does not include studies or comments made in professional publications that must be governed by general principles of ethics. If the publication harms any person or persons in his honor and good reputation, the proper names should be omitted.

Article 23. *The Lawyer must keep the strictest professional secrecy, even after having stopped rendering his services to the client. The lawyer has the right to refuse to testify against his client and may refrain from answering any question that involves the disclosure of the secret or the violation of the confidences made by his client. Nor may the Lawyer communicate to third parties what comes to his knowledge on the occasion of his profession, judicial or administrative functions. Everything that a lawyer deals with the representative of the opposing party, or knows about his status as an official of the justice or public administration, is included within the professional secrecy.*

Article 24. *The duty to keep professional secrecy extends to the confidences made by third parties to the Lawyer by reason of his profession and to those derived from the conversations necessary to reach an agreement that he does not make. The secret must also include the confidences of colleagues. The lawyer must not intervene in matters that may lead him to reveal a secret, or to use for his own benefit or that of his client the confidences that he has received in the exercise of his profession unless he obtains the prior written consent of the confidant. The previous prohibition extends to the secrets that the Lawyer knows through his associates, employees or dependents of these.*

“Article 5. ... 5.5 Confidentiality and Professional Secrecy.

The relationship of the Collegiate with the client is the primary element in professional practice. For such a relationship to be fully successful, it must be based on a responsible commitment, loyal and authentic, which imposes the strictest professional secrecy.

The Collegiate is obliged to keep professional secrecy and not to reveal for any reason the facts, data or circumstances of which he has knowledge in the exercise of his profession, unless authorized by him or the interested parties or is required to do so by court order. In these cases, their responsibilities must be safeguarded in the leave no room for doubt. However, you can consult or exchange impressions between the members of the College on matters of judgment or doctrine, without identifying the persons or business in question.

The evidences of the work of a Collegiate, are private documents submitted to reservations that can only be known by third parties, prior authorization of the client and the same Collegiate.

The Collegiate shall take the appropriate measures so that both the staff at his / her service, as well as those from whom you get advice or assistance, faithfully respect basic ethical principles.

The Collegiate will be obliged to maintain a reservation on books, papers or information of institutions or people to whom he has provided his professional services, except in the cases contemplated by legal provisions”.

“Article 168. GENERAL LAYOUT. *The resolutions that determine taxes and their accessories, those that impose sanctions or those that deny the refund or return of taxes can be reviewed by:*

- 1) *Ex officio review procedures; and,*
- 2) *Procedures through administrative remedies.*

Article 169. KINDS OF ADMINISTRATIVE REMEDIES.

- 1) *The taxpayers, the intervening in a process, as well as the third parties to whom an actor resolution directly causes a prejudice, they have the right to appeal it in the terms established in this Code. Who appeal an administrative resolution, can withdraw the appeal at any time prior to the resolution;*
- 2) *The resolutions indicated in the numeral above, can be appealed through:*
 - a) *The Appeal for Replacement;*
 - b) *The Appeal; and,*
 - c) *The Extraordinary Appeal for Review.*
- 3) *Only administrative resolutions can be reviewed to which the numeral 1), when they recognize rights or establish obligations, as well as the formalities that resolve directly or indirectly the matter;*
- 4) *Administrative remedies must be exercise only once in each administrative procedure and never simultaneously; and*
- 5) *The error in the qualification of the resource by the appellant is not an obstacle for processing provided that the written is deduced its true character”.*

"Article 105. *The deadlines for the presentation and answer of the claim, for the proposition and evacuation of the evidence and to formulate conclusions, are reduced by half in relation to this procedure."*

CHAPTER V RIGHTS OF THE TAX OBLIGATES

"Article 55.- RIGHTS AND GUARANTEES OF THE TAX OBLIGATES. In addition to those established by other laws, the following are the rights of taxpayers:

- 1) *Right to be treated with decorum, respect, dignity, impartiality and ethics by the personnel at the service of the Secretary of State in the Office of Finance (SEFIN), Superintendency of Customs Tax, Tax Administration and Customs Administration;*
- 2) *Right to register and obtain your National Tax Registry (RTN). Issuance for the first time must be immediate and free, in accordance with the procedure contained in this Code. When it is issued by electronic means, its emission and replacements must be free;*
- 3) *Right to the confidentiality of the data, reports and tax and customs records, as well as the information contained in the declarations, reports and studies of the taxpayers presented before the Secretary of State in the Office of Finance (SEFIN), Superintendency Customs Tax, Tax Administration and Customs Administration, in the terms provided by Law;*
- 4) *Right to be informed in writing and verbally; and be assisted personally, by the Secretary of State in the Finance Office (SEFIN), the Customs Tax Superintendency, the Tax Administration and Customs Administration, in the exercise of their rights and the fulfillment of their obligations;*

- 5) *Right to carry out all the requests and questions that are formulated in the tax application procedures, as well as to obtain access to the files and other cases brought before the competent administrative instances;*
- 6) *Right to obtain a copy of: a) The documents that make up the files as long as they are not in the process of resolution; b) The declarations, reports and studies that the Tax Obligor has submitted; c) Other actions carried out under the terms provided in the Law, except those derived from tax investigations that have not been concluded; and, d) Right to obtain a full copy of all the actions contained in the file, which must be delivered once the respective administrative instance has concluded an audit and the corresponding resolution is notified.*
- 7) *Present complaints or complaints to the National Human Rights Commission (CONADEH) and other competent bodies, when the corresponding administrative body does not guarantee or respect their rights;*
- 8) *The right not to provide the documents already presented in any diligence, file or procedure, which are in the possession of the Secretary of State in the Office of Finance (SEFIN), the Customs Tax Superintendency, the Tax Administration or the Customs Administration;*
- 9) *Right of repetition of the payments made and return of the excess payments that proceed within the period established in this Code;*
- 10) *Right to be applied ex officio or at the request of a party, the prescription of the corresponding action, to determine obligations, impose sanctions and demand the payment of the tax or customs debt in the cases provided for in this Code;*
- 11) *Right to know the status of the administrative actions and the processing of the procedures in which it is a party and to have physical access to them;*
- 12) *Right to identify the personnel of the Secretary of State in the Finance Office (SEFIN), the Customs Tax Superintendency, the Tax Administration and the Customs Administration, under whose responsibility the procedures in which they are a party are executed;*
- 13) *Right to be informed at the beginning of the verification or inspection actions, about their nature and scope, as well as their rights and obligations in the course of such actions and that they are developed within the legal deadlines;*
- 14) *Right to rectification of statements in accordance with the provisions of this Code;*
- 15) *The right that no material action limits the rights established in this Code and other tax and customs laws, without the decision that serves as a legal basis having been previously adopted and legally communicated;*
- 16) *Right to challenge the resolutions issued by the Secretary of State in the Finance Office (SEFIN), the Customs Tax Superintendency, the Tax Administration and the*

Customs Administration, that affect them, in accordance with the provisions of this Code and to obtain an express statement of the same within the terms contained in this Code;

17) Right to the presumption of innocence, due process, to be heard and defeated in court and to the right of defense; Y,

18) Right to present allegations and evidence, within the terms of the Law. Valid evidence in favor of the taxpayer is any information that has been published in official electronic media of the Tax Administration or the Customs Administration, when applicable.

The taxpayers can act by themselves or, through a procedural representative or legal representative.

The aforementioned rights do not exclude those set forth in other laws and those derived from International Treaties or Conventions.. "

" Article 56.- INFORMATION RIGHTS IN FAVOR OF THE TAX OBLIGATOR AND OBLIGATION OF STATE ASSISTANCE TO FACILITATE VOLUNTARY COMPLIANCE. The Tax Administration and the Customs Administration must provide assistance to taxpayers in the voluntary fulfillment of their obligations, through the means they deem appropriate, in particular their sites or other electronic mechanisms and, for this, they must:

1) Provide the taxpayers with computer assistance programs for the preparation and presentation of returns, self-assessments and data communications, as well as for the fulfillment of other obligations;

2) Explain the tax and customs regulations using clear and accessible language as far as possible and, in cases where they are complex in nature, prepare and distribute by physical or electronic means, explanatory brochures to taxpayers;

3) Prepare, socialize and distribute the declaration forms so that they can be completed by the taxpayers and informing the dates and places of presentation;

4) Disseminate, publish and update the procedures and requirements of all the actions that, by mandate of this Code, other laws or regulations must be carried out before specific administrative bodies of a tax and customs nature, and must also publish the flow charts of the processes corresponding, detailing the instances and agencies that must dictate and pronounce for each process;

5) Indicate precisely which is the document to present, in the requirements by which the taxpayers are required to submit declarations, communications, reports and other documents to which they are required;

- 6) Disseminate and keep updated all the information that refers to instructions, help software, procedures, procedural norms for the application of regulations in tax and customs matters, among others, on its electronic portal;
- 7) Systematize by dates and thematic axes the legislation, regulations and other promulgated and current norms, in such a way that they facilitate their knowledge by the taxpayers. Likewise, it must keep separately, all those rules that have been repealed for permanent consultation;
- 8) Maintain available to taxpayers, by electronic and similar means, the updated versions of the tax and customs procedural rules. Administrations must update their files of standards within a period of no more than ten (10) business days after their publication in the Official Gazette "La Gaceta";
- 9) Disseminate among taxpayers the resources and means of defense that can be asserted against the resolutions and acts of a general nature issued by public entities related to tax and customs matters;
- 10) Promote training workshops for taxpayers from different social sectors and the country's economy, on the application of tax and customs regulations; likewise, install tax and customs help and instruction tables during the main periods for filing declarations or when it is intended to approve new laws of a tax or customs nature;
- 11) Disseminate, publish and keep updated information on tax collection goals and the behavior of tax revenues; all information related to imports through the country's customs, informing at least about the imported goods and merchandise, their tariff positions and taxes paid; as well as all the statistics that the Secretary of State in the Office of Finance (SEFIN) and the Tax Administration and Customs Administration produce on the fulfillment of income goals, tax evasion, the behavior of taxpayers, among others;
- 12) Publish and update the programs, projects and operational plans of the different work units on an annual basis. Likewise, the criteria for classifying the different categories of taxpayers, the criteria for carrying out the collection functions; Y,
- 13) Take any other action to achieve the stated objectives. "

"Article 57.-SPECIAL DEFENDER'S OFFICE FOR THE PROTECTION OF THE TAX OBLIGATOR. The Special Ombudsman for the Protection of the Tax Obligor is created, as a unit or agency attached to the National Commissioner for Human Rights (CONADEH), so that within the framework of its powers in the defense of the fundamental rights of natural or legal persons, With or without legal personality, ensure the rights of taxpayers, before the tax and customs authorities. "
