The Australian Taxation Office, through Australian Business Registry Services continues its administration of director identification numbers (director ID). Director ID was delivered through the now ceased Modernising Business Registers (MBR) program. Approximately 85% of directors now have a director ID, having successfully verified their identity. Director ID is helping prevent the use of false and fraudulent director identities, and to identify illegal conduct including phoenix activity, which may have otherwise remained undetected. Illegal phoenix activity is a practice where companies liquidate, wind up or are abandoned to avoid paying debts.

The ATO continues to use data to pre-fill income tax returns. In some cases, the pre-filled data is used to prompt taxpayers to check prior year returns where the pre-filling differs from other taxpayers in similar circumstances. The ATO has said in its most recent Annual Report:

"Data underpins our client services, our early intervention activities, and our goal of prevention rather than correction. In 2022–23, we used data and analytics to:

- pre-fill over 104.4 million pieces of data, including salary and wages, interest and dividends, and Australian Government allowances and payments
- provide over 490,000 real-time prompts to taxpayers to check amounts in their 2021–22 income tax returns, resulting in the protection of an estimated \$61.1 million of revenue
- send nearly 1.1 million informative pre-fill messages to clients to consider the tax consequences of their crypto asset sales when completing their 2021–22 income tax returns
- provide over 540,000 real-time prompts to taxpayers to check amounts in their business activity statements prompt over 11,000 self-preparing sole traders to check amounts reported in their 2021–22 tax return where the amounts differed to those in similar circumstances 16% of those prompted made adjustments as a result."

In June 2023, the ATO released an updated version of the Taxpayers' Charter. The new charter is named "Our Charter" and reduced the size of the document from 60+ pages down to 3 pages.

The refresh and re-issue of the charter was, in part, a result of the a review of the Inspector-General of Taxation and Taxation Ombudsman examining the Effectiveness of the Australian Taxation Office's communication of taxpayers' rights to complain, review and appeal.

The refreshed Charter sets out, amongst other things, three steps for taxpayers to take if they are dissatisfied with the ATO's service:

"As a first step, discuss your concerns with an ATO officer who will try to resolve your issue. You may have been provided with a specific contact you can speak with, otherwise you can contact us.

If you're not satisfied, you may ask to talk to a manager.

If this still does not address your concerns, you can provide feedback to improve our processes or lodge a formal complaint."

Finally, the refreshed Charter informs taxpayers that "If you're not satisfied after making a complaint with us, you can contact the Inspector-General of Taxation and Taxation Ombudsman for an independent investigation."

The ATO also reiterates that "Making a complaint will not affect your relationship with us."
